	side view. One full front view, one full hind view, one extra of the best side view for attachment to the registration certificate. This extra view is best no larger than a 3x5 to fit
	properly onto the final certificate. Clear, good quality photos showing the complete horse, void
	of shadows and obstructions can eliminate a later request for additional photos. Be sure that
	any markings under mane or forelock are visable.
